President's Report

Helen gave a summary of the ATESOL ACT yea and the ongoing efforts of the committee under difficult circumstances. She acknowledged the work of current 2022 members and those who had discontinued Committee membership, particularly Mei French who has served for several years as ATESOL ACT Secretary and Vice-President Christina Braun who had put forward numerous initiatives to improve communication.

The report noted events and professional learning opportunities delivered with collaborations between ATESOL ACT and the National Museum Showcase and Companion House. Other events included presentations by those supported to attend the ACTA conference (Lesley, Mali and Ugyen), and an introduction to the new on-line portal for adult learners funded by the Department of Home Affairs. Also noted was the re-development of the ATESOL ACT website. The devoted and long-standing voluntary work of Lesley Cioccarelli in maintaining the earlier version was acknowledged. Paul Taylor will take on the technical side of this role, together with other communication tasks, and will be remunerated on an hourly basis for his services.

Helen noted the continuing decline in our membership (also in most other jurisdictions), reflecting the decimation of EAL/D programs in schools, the huge effects of the COVID pandemic on teacher workloads, and the Government's current employment policies that show no interest in supporting principals to hire qualified EAL/D teachers. 2023 Early Bird membership has increased from 38 in 2022 to 51 but below 2021 figures (77). She previewed a motion to reduce membership payments for early career educators. She then listed important advocacy work done through our national peak body, the Australian Council of TESOL Associations (ACTA) and invited members to consider joining an ACTA Consultancy Group.

She concluded by warmly encouraging those present to consider joining the 2023 Committee so as to lighten the load of continuing Committee members and to enjoy the contact with fellow EAL/D professionals in the ACT.

Treasurer's Report

Treasurer Janica Morella reported on the current financial status of ATESOL ACT. Our income is based on membership and professional learning events. Due to the generosity of PL presenters and low cost on-line PLs during COVID, our balance sheet is healthy. To give back to members, we supported three people to present papers at the ACTA conference.

Janica tabled the Auditor's Report, which had just been received, and read a Statement from the Auditor. She explained that the audit had been delayed due to the auditor's illness and hospitalisation. Hardcopies of these were available to view.

Janica concluded by noting again that our financial health depends entirely on income from professional learning events and membership.
